ORDER:

Government vide G.O 9th read above, had issued a preliminary notification to amend Rule 81 of the Telangana Motor Vehicles Rules, 1989 to enhance the fee for reservation of special numbers and the same was published in the Telangana Gazette vide No.G-575 Part-I Extraordinary, dated 13.08.2025 for the information of the general public, as required under sub-section(1) of section 212 of the Motor Vehicles Act, 1988 (Central Act,No.59 of 1988), duly calling the objections or suggestions within Thirty (30) days.

- 2. Whereas no objections or suggestions have been received from the general public within the period specified, in respect of the preliminary notification and after due compliance with the procedure prescribed under the law, the Government hereby publishes the final notification in the said matter.
- 3. Accordingly, the following notification shall be published in an extraordinary issue of the Telangana Gazette, dated:15.11.2025.

NOTIFICATION

In exercise of the powers conferred by section 65 of the Motor Vehicles Act, 1988 (Central Act No.59 of 1988), the Government of Telangana hereby makes the following amendment to the Telangana Motor Vehicles Rules, 1989, issued vide G.O.Ms.No.216, Transport, Roads & Buildings (Transport-II) Department, dated: 07.08.1989 and published in the Rules Supplement to Part-I Extra-Ordinary issue of the Telangana Gazette, dated:25.08.1989, and as subsequently amended from time to time, the same having been previously published as required under sub-section (1) of section 212 of the Motor Vehicle Act,1988(Central Act.No.59 of 1988).

AMENDMENT

In the said rules, in rule 81,

- 1. sub-rule (1), (2) and (4) shall be omitted.
- 2. for sub-rule (3), the following shall be substituted, namely,-
 - "(3) The Registering Authority may on an application made to it through online in the Transport Department portal i.e. www.transport.telangana.gov.in by owner of the vehicle, reserve the special numbers within thousand from the last number assigned in serial order on the date of application.
 - i. On payment of fee of Rs.1,50,000/- (Rupees One lakh Fifty thousand only) for the number (9999);
 - ii. On payment of fee of Rs.1,00,000/- (Rupees One lakh only) for any one of the numbers (1,9,6666);
- iii. On payment of fee of Rs.50,000/- (Rupees Fifty thousand only) for any one of the numbers (99, 999, 3333, 4444, 5555,7777);
- iv. On payment of fee of Rs.40,000/- (Rupees Forty thousand only) for any one of the numbers (5,6,7,123, 333, 369, 555, 666, 777, 1111, 1116,1234,2222,2277,2345,2727,3339,3366,3456,3699,4455, 4545, 4599, 6669,6789,8055, 8888);
- v. On payment of fee of Rs.30,000/- (Rupees thirty thousand only) for any one of the numbers (3,111,234, 567,1188, 1818, 1899, 1999, 2799, 3636,3999,5678,5999, 6999, 7999, 9009);
- vi. On payment of fee of Rs.20,000 /- (Rupees twenty thousand only) for any one of the numbers (2, 4, 8, 11,18, 27, 36, 39, 45, 55, 77, 143, 222, 405, 444,456,459, 786, 789, 909, 1112, 1122, 1212, 1233, 1269, 1314, 1359, 1889, 2223, 2255, 2259, 2349, 2525, 3335, 3344,3399,3555,3789, 3888,3969, 4446, 4554, 4567, 4777, 4959, 5445,5559,5589,5599, 5666,5679, 5859, 6336, 6699, 6777, 6786, 6969, 7779, 7799, 7979, 8889, 8899, 8999, 9099);
- vii. On payment of fee of Rs.6,000/- (Rupees Six thousand only) for any one of the numbers other than those mentioned against the clause (i),(ii),(iii),(iv),(v) and (vi) above in respect of all vehicles except two wheelers for which a fee of Rs.3000/- shall be charged;

Provided that any current number can be reserved on payment of Rs.2000/- (Rupees Two Thousand only).

- viii. The application for reservation of numbers shall be submitted online in the Department portal www.transport.telangana.gov.in by paying the requisite fee online from 8.00am to 1.00pm. No application shall be received personally under any circumstances.
- 3. For sub-rule (5) the following shall be substituted, namely:-
 - (i) If there is more than one application for a particular registration number, the reservation shall be made by way of submitting the bids

online from 2.00pm to 4.00pm. The number shall be allotted to the highest offer for those who have filed bids.

- (ii) If any applicant has not submitted the bid, the fee shall be forfeited.
- (iii) Ten percent of the reservation fee for special numbers shall not be refunded to the unsuccessful bidders.
- (iv) The bid amount offered shall not be less than the fees referred to in clause (i),(ii),(iii),(iv),(v),(vi) and (vii) of sub-rule (3);
- 4. For sub-rule (6) the following shall be substituted, namely:-

"The number reserved under sub rules (3) (i), (ii), (iii), (iv),(v),(vi),(vii) shall be allotted on production of the vehicle and registered as per the procedure prescribed in the Motor Vehicles Act, 1988 and rules made there under. The reservation shall be cancelled if the vehicle is not produced within fifteen (15) days from the date of reserving the number. The number reserved shall be re-notified immediately and the procedure as per sub rules (3) (i),(ii),(iii),(iv),(v),(vi) and (vii) shall be followed after cancellation of the reservation. If no applicant applies for the number or numbers, the said number or numbers shall be referred to the Transport Commissioner at intervals decided by him for re-notification or further action".
