ORDER:

In the G.O. 1st read above, the ITE&C Dept., has issued Telangana Electric Vehicle & Energy Storage Policy 2020-2030 to encourage the Electric Vehicles in the State by providing the incentives i.e., exemption of Road Tax, registration Fee and retro-fitment incentive for the first few Electric Vehicles, purchased & registered with in the Telangana State as mentioned below:-

Vehicle Category	Incentive Provided	No. of Vehicles eligible for Incentives
Electric Two Wheelers	100% exemption of road tax & registration fee	2,00,000
Electric Three-Seater Auto-Rickshaws	100% exemption of road tax & registration fee	20,000
	Retro-fitment incentive 15% of the retro-fitment cost (capped at Rs.15,000 per vehicle)	5,000
Electric 4-Wheeler commercial passenger Vehicles such as Taxi, Tourist Cabs, etc.	100% exemption of road tax & registration fee	5,000
Electric Light Goods Carries - including Three Wheelers (goods) and e-carriers	100% exemption of road tax & registration fee	10,000
Electric 4-Wheeler Private Cars	100% exemption of road tax & registration fee	5,000
Electric Buses	100% exemption of road tax & registration fee	500
Electric Tractors	100% exemption of road tax & registration fee (as per the existing rules/guidelines applicable for tractors by Transport Department, Govt. of Telangana)	

2. In the G.O. 2nd read above, Government have issued orders for exemption of Motor Vehicle Tax payable in respect of the Tractors and Tractor-Trailers for Agriculture purpose under the Telangana State Motor Vehicles Taxation Act, 1963.

3. In the G.O. 3rd read above, Government have issued orders for exemption of Motor Vehicle Tax payable in respect of the four categories of vehicles i.e., Passenger Auto Rickshaws (three-wheeled contract carriages), three-wheeled auto goods carriages under the Telangana State Motor Vehicles Taxation Act, 1963.

4. In the circumstances reported by the Transport Commissioner, Telangana, Hyderabad, in his letter 4th read above, after careful examination of the matter, Government hereby exempt Registration fees in respect of Electric three seater Auto Rickshaws for first 20,000 vehicles, retro fitment incentives 15% of the retro-fitment cost (capped at Rs.15,000/- per Vehicle) for first 5000 vehicles and Electric Light Goods Vehicles including three wheeled Goods Vehicles for first 10,000 vehicles and Electric Tractors purchased in the Telangana State as per Section 211 of Motor Vehicle Act, 1988 read with Rule 91 of Transport Motor Vehicles Rules, 1989 and order that the following Notification shall be published in the extra-ordinary issue of Telangana Gazette, dated.02.02.2021.

NOTIFICATION

In exercise of the powers conferred by Section 211 of Motor Vehicle Act, 1988 read with Rule 91 of Telangana Motor Vehicles Rules, 1989, the Governor of Telangana hereby grant exemption of Registration fee in respect of Electric three seater Auto Rickshaws for first 20,000 vehicles, Retro fitment incentives 15% of the retro-fitment cost (capped at Rs.15,000/- per Vehicle) for first 5000 vehicles and Electric Light Goods Vehicles including three wheeled Goods Vehicles for first 10,000 vehicles and Electric Tractors purchased and registered in the Telangana State.
