NOTIFICATION

In exercise of the powers conferred by Section 65 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Motor Vehicles Rules, 1989, issued in G.O.Ms.No.216, Transport Roads & Buildings (Tr.II) Department, dated the 7th August, 1989, and published at pages 1-315 of the Rules supplement of Part-I Extra ordinary issue of the Andhra Pradesh Gazette dated the 25th August, 1989 as amended from time to time the same having been published as required under sub section (1) of section 212 of the said Act.

AMENDMENT

In Rule 81 of the said rules:-

1. sub rule (2) shall be omitted
2. for sub rule (3), the following sub rule shall be substituted, namely:-

“(3) The registering Authority may on an application in form RRMA made to it by owner of the vehicle reserve the special numbers within thousand from the last number assigned in serial order on the date of application.

- (i) On payment of fee of Rs.50.000 (Rupees fifty thousand only) for any one of the numbers 1, 9, 999, 9999.

(PTO)

- (ii) On payment of fee of Rs.30,000 (Rupees thirty thousand only) for any one of the numbers 99, 333, 555, 666,777,888, 2222, 3333, 4444, 5555, 6666, 7777, 8888.
- (iii) On payment of fee of Rs.20,000 (Rupees twenty thousand only) for any one of the numbers 123, 222, 369, 444, 567,786,1111, 1116, 3366, 3456, 4455.
- (iv) On payment of fee of Rs.10,000 (Rupees ten thousand only) for any one of the numbers 3, 5, 6, 7,111, 234, 306, 405, 789, 818, 909, 1188,1234, 1314, 1818, 1899, 2277, 2772, 2345, 2727, 2799, 3636, 3663, 3699, 4545, 4554, 4567, 4599, 5678, 6336, 6633, 6789, 7227, 7722, 8118, 8811, 9009, 9099.
- (v) On payment of fee Rs.5,000/-(Rupees five thousand only) for any one of the numbers other than those mentioned against the clauses (i) (ii) (iii) and (iv) above in respect of all vehicles except two-wheelers for which a fee of Rs.2,000/- shall be charged. When there is application for allotment for four- wheelers and two - wheelers for the same number, priority shall be given to four- wheeler applicants.

Provided that any current number can be reserved on payment of Rs.1000/-(Rupees one thousand only)

- (vi) The applications for reservation of numbers shall be dropped in a drop box (sealed box) along with the required fee up to 1.00 P.M. No application would be allowed to be dropped in the drop box after 1.00 P.M. On any working day no application shall be received personally under any circumstances".
