NOTIFICATION

In exercise of the powers conferred by section 3 of the Andhra Pradesh Motor Vehicles Taxation Act, 1963 (Andhra Pradesh Act 5 of 1963), the Governor of Andhra Pradesh hereby makes the following amendment to the notification issued in G.O.Ms.No.68, TR&B (Tr.I) Department, dated the 13th April, 2006.

AMENDMENT

In the schedule to the said notification (1) in item (4) (iv) (a) after entry (ii), the following entry shall be added, namely:-

“(iii) Exceeds 1000 Kms. Rs.3675/-”.

- 2 In the Explanation III to Item 4(iv), after clause (1) the following shall be added namely:-

“(ii) In case of a Motor Vehicle plying without a permit granted under Motor Vehicles Act, 1988 be-reckoned, as above 1000 Kms”

- 3 In the Item 4 V (a), after entry (a), the following entry shall be inserted, namely:-

“(aa)Vehicles permitted to carry more than Six (6) persons and plying as contract carriages on Inter State Routes for every passenger (other than the Driver and Conductor / Attender, which the vehicle is permitted to carry.... .. Rs.3675-00”.

- 4 In the Explanation VI to Item 4 (v), after clause (iii) the following shall be added, namely:-

“(iv) Where contract carriages covered by Inter State, State wide, District-wide permits and Idle Contract Carriages are misused as Stage Carriages, tax at the rate of Rs.3,675/- per seat per quarter shall be leviable”.
