**NOTIFICATION**

In exercise of the powers conferred by sub-section (1) of section 9 of  
the Andhra Pradesh Motor Vehicles Taxation Act, 1963 (Andhra Pradesh Act  
5 of 1963), the Government of Andhra Pradesh hereby orders that in respect  
of the personalised vehicles owned by the Officers of Reserve Bank of India  
working in this state on transfer or on deputation or on duty, tax shall be  
levied and collected at the rates as indicated below:

1. 3 years Tax in the first instance at the rate of 3/12th of the applicable  
life tax ie., 1/4th of the Life Tax applicable .
2. Subsequently, Annual Tax at the rate of 1/3rd of the Tax levied above,  
if the vehicles continue to ply in the State beyond three years of initial stay.

**Conditions:**

1. This facility is applicable only to those employees on whose name the  
motor vehicle is registered.
2. The employees must be working in this state on transfer or on  
deputation or on duty.
3. The employee must get the address changed into the rolls of the state  
and get the number changed in Andhra Pradesh Series.

4. If the vehicle is sold in this state, balance life tax shall be paid calculated from the date of first entry.

5. No refund is admissible under the scheme.
