ORDER:

In the circumstances explained by the Transport Commissioner, Hyderabad, in his letter read above, Government have decided to fix speed governors to Education Institution Buses, Light Commercial Vehicles and Maxi Cabs on the rolls Hyderabad, Cyberabad area of Rangareddy, Nalgonda and Chittoor Districts.

NOTIFICATION

In exercise of the powers conferred under Section 110 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) read with rule 118 of Central Motor Vehicles Rules 1989, the Governor of Andhra Pradesh hereby order that Education Institution Buses, Light Commercial Vehicles (goods vehicles), and Maxi cabs (Passenger vehicles) on the rolls of Hyderabad, Cyberabad area of Rangareddy, Nalgonda and Chittoor Districts and the vehicles of these categories from outside operating in the above areas shall be fitted by the operators of these vehicles with speed governors limiting maximum speed at 65 Kilo Meters per hour except down an incline from the date to be notified by the Transport Commissioner. The speed governor shall be sealed with an official seal of the Regional Transport Authority concerned in such a way that it cannot be removed or tampered with, without the seal being broken.
